<p><i>Air brakes</i> are not an endorsement. Applicants who have passed the air brake written and driving exams will not have the air brake restriction (1) on their license.</p>		

CDL Restrictions

- 1- No Air Brake Vehicles
- 2- Intrastate Only Under 21, Vision, Insulin, and Medical
- 3 -CDL Bus, No Longer Used
- 4- CMV less than 2600
- 5- No Tractor Trailers
- 6- No Class A passenger vehicles
- 7- No Class B passenger vehicles

School Bus Drivers

CDL fees reduced. (**proof of employment not req**) **Reference statute 322.21**
 Must pass School Bus & Passenger written exams.
 Requires CDL skills testing with a 3rd party tester.

CDL Vision

Applicant must have 20/40 vision in each eye for interstate commerce.
 School bus endorsement requires 20/40 vision...no exceptions.

Driving Exams

Applicant is required to complete the driving exams with a 3rd party.
 Tester at applicant’s expense. List is available on the intranet.

Instructional Permits

Permits are valid for 180 days (Instructional)
 Two permits per CDL vehicle class
 Permits are valid for 60 days (Real ID)

Florida CDL Statute

- Must be Florida resident322.03
- Class E for disqualified CDL driver.....322.251
- Intrastate operation..... 322.11(1) b
- Test of knowledge in certain vehicles322.57
- Hazardous materials renewal 322.12(4) b
- Class of Licenses A, B, C, E322.54
- Alcohol .04 disqualifications322.61

CDL Medical Card

If a driver certifies in a category which requires a medical card
 Driver must present a valid medical card less than two years old.

CDL – Out-of-State Checklist

- Vision & Medical - discuss possible restrictions.
- CDL license fees explained.
- Previous states licensed in the last ten years?
- Valid medical card presented?
- Real ID compliant?
